I commit to withdrawing my candidacy if any of the above declarations are no longer true.

I have submitted a request for a criminal records check and a request to authorize the criminal records check to be forwarded to the election officer. I am attaching evidence that a request for a criminal records check to be forwarded to the Electoral Officer has been submitted.

I consent to the Electoral Officer taking all necessary steps to confirm that the information contained in this certificate is accurate.
